The completed and signed registration form for trade stall space should be sent to the 52 nd KSDC office and should be accompanied by the payment of the applicable deposit .

All requests for the stall space received at the office will be considered according to the time of the receipt of accompanying deposit and shall be considered on first come first serve basis. Every effort will be made to grant the exhibitors their preferred location.

However the organisers have the absolute discretion in the admission of exhibitors and in the event of any change to the floor plan the organisers reserve the right to the final decision.

Rules and regulations contract for TRADE FAIR

- The following rules and regulations will govern the trade fair at the 52nd Kerala State Dental Conference at Sports Hub and Convention Center -Trivandrum, being held from **MAY 14 & 15 , 2022.**
- To avoid any misunderstanding, please read the rules and regulations and enclosed contract carefully.
- The rules and regulations constitute an integral part of your contract.
- An authorized signature on the attached application confirms acceptance of the 2021 rules and regulations.

Setting up of Trade stalls

- Trade fair area will be made available to the exhibitors on Friday 13, MAY 2022 by 11 am.
- All stall preparations must be over by 7.00 am on Saturday 14, MAY 2022 .
- Exhibitors can register from Friday 13, MAY 2022 by 11 am.
- The registration desk will re-open on Saturday, 14, MAY 2022 .

Trade fair Dates and Hours

- Saturday, MAY 14, 2022. 9.00 am - 6.00 pm
- Sunday, MAY 15 , 2022. 9.00 am - 6.00 pm

Each Stall Includes

- Aluminium powder coated exhibition stalls includes system table - 1No., Black folding chair - 2nos., Spot light - 2 nos., 15 Amp Power plug - 1 no., Dust bin - 1 no.

Privileges for stalls

- Every stall will be provided with two food coupons. This coupon is non-transferable and it should be informed during registration process as to the beneficiary of these entitlements.
- Other promotional aspects would be communicated to you in due course .

Conditions for Participation as Exhibitors

- 1) While every attempt will be made to ensure that all aspects of exhibition and sponsorship mentioned will take place as announced, the organizer reserves the right to make changes if the situation requires.
- 2) Trade fair stalls will be allotted on first come- first booked basis only. The organizer reserves the right of final decision regarding allocation of exhibition booths. Acceptance of trade fair applications will be at the sole discretion of the organizer.
- 3) The organizer reserves the right to decline applications based on any association, direct or indirect, that doesn't uphold the objectives of the conference without assigning any reason whatsoever.
- 4) Filled up application forms should be accompanied by 50% of the total amount as deposit payment. Balance amount should be completed by 01/04/2022. Please attach a copy of remittance to Conference Secretariat.
- 5) If the appropriate amount is not paid by the due date, your contract may be cancelled without refund of any deposit amount. If the payment is done by cheque give sufficient time for collection.
No Trader will be allow to occupy the stalls, if the payment is not credited to our account in the stipulated time.
- 6) Any loss or damage claims or disputes relating to the sponsorship package / trade fair package or the conference will be governed by the Indian Law and courts of Trivandrum jurisdiction only.
However in the event of a dispute, both parties agree to arbitration before approaching any court of law.

7) Exhibitors will need to comply with exhibition rules and regulations laid down by Sports Hub and organizers. No construction or allied work will be allowed in the stall after the deadline given above. Spray painting as well as welding of stand panels with oil based paints and any inflammable materials inside the halls are strictly prohibited. Smoking is strictly prohibited in the entire exhibition/conference area.

8) No projection will be allowed which may cause any obstruction to the neighbouring stalls. Playing of loud music or sound disturbing others is not allowed. Display materials, signboards, standees, roll ups, flag/bunting, furniture, equipments or exhibits should not protrude in to the aisles/ passage and not extend beyond the rental space. Stall construction is confined to the rented stand space only.

9) Exhibitors will be held liable and will be fined for any damage caused to the exhibition site by them (the agents/representatives/contractors/labourers etc) Please note that for any damage, the organizers will charge the exhibitor concerned to the extent of the damage caused.

Exhibitors should ensure that no pins, nails or screws are drilled in to the stall panels.

10) The organizer is not responsible for personal accidents damage to personal or private property of exhibitors. Therefore exhibitors who may wish to make their own arrangements with respect to personal insurance are advised to obtain insurance cover to get insurance of their exhibits/materials. Organizers are not held responsible for any insurance claim liability.

11) Once confirmed, booth space cannot be cancelled or transferred. No refund if postponement or cancellation of event due to reasons beyond organizer's control viz. acts of nature, riots, strikes etc. Any assigned booth space not claimed, occupied and no special arrangements have been made prior to the opening of the trade fair, maybe resold or reallocated by the organizers.

12) It is mandatory to have respective badges with the persons name deployed on the stalls to maintain a smooth access and security check.

13) All exhibits and respective contents are at the exhibitor's risk. The organizers will not be responsible for damage or loss by fire, riots, strikes etc. However, as an additional service to the exhibitors, general security will be provided for the protection of exhibits from Friday 13, MAY 2022 from 11.00 am - 6.00 pm Sunday 15, MAY 2022.

Cancellation policy

1) Cancellation of stalls once booked cannot be done after **15, APRIL 2022**.

2) All cancellations will have to be duly intimated to the office of the organizing secretary before the cut - off date through e-mail.

3) Cancellation will attract a deduction of 30 % from the refund amount.

4) If balance payment of the stall booking is not made before **1, APRIL 2022**, the organizing committee has the right to cancel the booking and re-allot the stall to other demandants.

5) If the stalls are not occupied before **8.00 am, 14, MAY 2022**, the organizing committee has the right to consider the status as cancelled and re-allot the stall to other demandants.

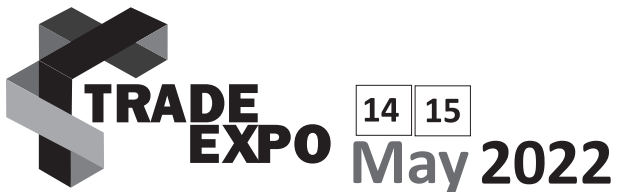
